BWL status as 2023 starts

- We have transitioned from an exploratory phase in 2022 of sensing if a BWL could be of use and interest in the Waterford bioregion, to a more solid phase where **BWL Waterford is a three year initiative that is now underway**.
- Funding is in place for a 60% weaver position and minor projects out 2023. Major and minor fundraising activities for both stakeholder participating projects and BWL weaving is a ongoing process.

Reflections on the Dunhill event - speakers

- **Grace O'Sullivan** Have us a real sense of believing transformation is actually possible. Appreciated the endorsement for weaving. We could include these concrete examples of policy change in the proposed Ambassadors Toolkit?
- Luis Camargo we could introduce weaving to PPN (Public Participation Networks) who sit on SPCs (strategic policy committees) in council work - important in bioregion. For example the environment and business SPCs. Get in touch with Muriel Tobin now John Hawkes has retired. There are 600+ groups attached to PPN – excellent way of circulating BWL activities and mobilising changemakers.
- Steve Collins: Brilliant example of livelihoods and biodiversity in harmony. Since the event we have connected interested parties and arranged a visit from the bioregion to Aronia Berries farm in West Cork. Apparently a good view across to other mountain sides with sheep. It maybe didn't come out from the talk how well qualified he is to talk about health benefits in wide context experience from famine of Ethiopia and the effects of extreme soil erosion on people's health.
- Helen Kavanagh we must all acknowledge the challenges of running such a centre in a rural setting very dependent on volunteering. We need a system change to bring about new funding models not relating to financial returns alone. Interesting to see how this would link to holistic 4 Returns model of BWL.
- **Donal Sheehan** Farming with Nature: very innovative and relevant. Would be great to see tested in the bioregion. And EIP is a good idea.
- **Mike Walsh** interesting to hear the science and the spectrum of opinions around environmental challenges and in particular if dairy is good/bad for increasing emissions. Would be good to hear this as an exchange of views in a debate (perhaps see biofarm link in report).
- **Kit Keawwantha, Fibreshed** very interesting, and especially in light of <u>Wool Feasibility Study</u> from July last year. and things Minister Noonan has been trying to do. Perhaps contact Minster Noonan about BWL again, in this and other contexts.
- Geert van der Veer super interesting, and inspired people in the room to think it was perfectly possible to try this model of co-owned farms. Question if there are cultural differences that might make it harder. Question of commercial dairy land being snapped up vs. sympathetic land owners. The fact the farmer gets a steady salary is important the unpredictability of farming in Ireland is a big part of the problem To have security of income could help encourage people to grow more vegetables Also nice with closeness of consumers and growers.


Participants' tips

Media

- Stories from the Waterside recommended website with many stories from the bioregion and beyond – search by river or place, and listen to live story reading at <u>this link</u>.
- Troubled Waters An episode of Eco Eye on RTE, watchable at <u>this link</u> suggesting there is enough money and a multitude of institutions in the water quality debate, but we need something else to enforce things as quality continues to decrease. Food is also so toxic 'What are we feeding our kids' was shocking, and many producers of chicken/carrots do not eat their own food.
- What are we feeding our kids? Documentary was on RTE. What bad food is doing to our brains.
- **Europe revealed** was on on RTE. **Feeding Europe** and **Nature Revealed** episodes are recommended, if depressing.
- A River Runs Through It age-friendly creative project.

Thoughts from participants (1/2)

- Joining people up is so important great that BWL does it. Intergenerational knowledge is so valuable. So is hope, collaboration.
- Empowerment of the farmer is so important a feeling of stewardship and they they hold the keys to change. No step is too small, 'a bit organic' is great but is difficult I the system today. Farmers hold the most powerful position in the world – we hold the key.
- Once organic always organic. Once a farm is organic it should not be possible to sell it onwards and out of organic certification, but at the moment there is no law or incentive not to do so.
- Changemaking as a concept is interesting. We could help by being BWL ambassadors a easy to use toolkit would help. Idea: make an Ambassador's Toolkit with key descriptions, manifesto and example case studies.
- Looking for a serious **science-based** talk on **marine** and fisheries in the bioregion e.g. what is happening at Helvik.
- **Beekeeping and conservation** so much more than honey bees. Need education centres, research and habitat support
- **Vulnerability** 94% of dairy has to be exported as milk powder, importing 4million tonnes of meat from Brazil. The supply chains in both systems are vulnerable. There should be more mixed farming



Thoughts from participants (2/2)

- **Cooperatives** are too big. We need **small** ones.
- Water quality the rules are there but are not being implemented. See Troubled Waters on RTE. One body should be accountable.
- The role of **supermarkets** labelling that 'insecticide may have been used in this food', subsidies. How to bypass the system through local food systems?
- Tax food that is produced badly
- Early intervention in nutritious food will save on health costs. But the system does not allow this. Obesity levels are highest in Europe, Damien O'Rielly in Farmers Journal – I only buy organic food.
- Look to Farm to Fork again, there are 20 lovely ambitions just that government regulations don't allow them to happen, e.g. pigs and chickens together on small scale farms. Scales we need and want need new laws.
- **Changing mindsets:** Use media more for BWL. Discussion of the power of commercial in lobbying, and alternatives such as the **Good Lobby**. Get the Ambassador Toolkit ready and then approach them. Also consider if it is willingness, capacity or awareness hold back change (Ashoka resources).
- Look to Denmark? In Åhus you can apply for fund to set up small growing-gardens



How can we find innovations on H2 that are captured by H3 rather than H1, thus lifting the emerging future we aspire to into the dominant position.




2. Sosiocracy

WILLINGNESS TO ACT.

The state of being willing to take action on the proposed change. There are multiple components of will:

1. Opinion, which is our stakeholder's belief or judgement about an issue, once they know something about it.

2. Intensity, which refers to the strength of a person's opinion.


3. Salience, which is how important and relevant an issue is to our stakeholder personally.

4. Receptiveness to a specific approach or its carrier which implies the attitude towards a concrete approach to address the problem, and attitude to people or organizations who carry it. 5. Willingness to take a particular action despite the risks or trade-offs that are associated with that action, which might imply angering peers or constituents who disagree.



FUNDING

BWL small grants Bioregional landscape funding



BWL small grants/seed funds

As part of our core funding from Commonland, made possible by Fund De Roeper, BWL Waterford has some small grants (total 17,500 in the pot currently) to **seed fund** and **catalyse** projects that could lead to **systems change** connected to our **manifesto** and **mission**.

We are open to ideas (get in touch!) regarding how these might best be used. Ideas that emerged through the catch-up events included:

- Use to concretely follow up on the three holistic ideas in the Dunhill event fund concept development by a relevant person?
- Go through earlier workshops and see if other ideas could be brough to concept or prototype if someone paid to do so.
- Use funds to pay for time that is otherwise voluntary and yet should be valued.
- Capacity-building courses systems change, ecosystem financing, 4 Returns and more co-partner for these and use seed funds to develop courses?
- Promote weaving in big institutions need funds to stimulate co-weaver roles?
- Dingle films about climate challenges sand farming? Could we screen them? Invite them over, and talk about biodistricts too.
- Heritage keeper schools? Find out more about these from Burrenbeo
- Pay for some articles and media work on this films from the manifesto-people reading it.
- Commission future visioning workshops what will our landscapes look like in 20 years?
- Farmers inspiring farmers is enough happening on that front?

The participants mandated Sarah to develop some of these further – she'll do so and inform in next email before any funding decisions made.



Grown and eaten with passion, without which we will fail. Inspirational Easy to get and affordable for all. Connected to people and communities




